- **I.** City Council Meeting was called to order by Mayor Gillespie at 7:00 p.m.
- **II.** Alderman Ehmann gave the invocation.
- **III.** Mayor Gillespie led the Pledge of Allegiance.
- **IV.** Roll Call: Present were: Mayor Gillespie, Alderman Marroquin, Garbutt, Ehmann, Morgan and Robbins.
- V. Minutes of Previous Public Hearing and City Council Meeting of April 7, 2009 were approved as written.
- VI. Treasurer Report was given.
- VII. Citizen Participation

Wayne Jewell expressed his thanks for the item on four wheelers driving in the alley that was put in the newsletter. The problem seems to have been lessened.

IX. Reports from Standing Committees

Item A: Planning & Zoning reported a meeting was held on March 16, discussion of stop signs and speed deterrents was discussed, any ideas and suggestions are welcome. Zoning issues were also discussed.

Item B: Parks & Recreation reported the Easter egg hunt was a huge success and hopefully a larger one can be held next year.

Item C: VFD reported so far this year ten calls have been responded to, most of those were mutual aid calls. Members are still needed. Dick Ehmann was thanked for fixing the van.

X. New Business: Discussion and Possible Action

Item A: Approve/Disapprove Mayor Gillespie to enter into a contract with Allied Waste for brush/bulk pick up

Discussion occurred concerning the need for a regular pick up, vacant lot included in pick ups, cost, and if the garbage billing including a fee along with funds from the general fund to cover the pick ups. Item B: Approve/Disapprove Ordinance Restricting Parking of Explosive Vehicles within City Limits Mayor Gillespie
