


**CITY OF INGLESIDE ON THE BAY**  
**CITY COUNCIL MEETING**  
**July 16, 2013**

- I. City Council Meeting was called to order by Mayor Gillespie at 7:00 p.m.
- II. Alderman Ehmann gave the invocation.
- III. Mayor Gillespie led the Pledge of Allegiance.
- IV. Roll Call: Present were: Mayor Gillespie, Alderman Tucker, Merrick, Ehmann and Robbins.  
Alderman Skinner was absent.
- V. Minutes of Previous City Council Meeting of June 28, 2013 were approved as written.
- VI. Treasurer Report was given.
  
- VII. Citizen Participation  
Hector Marroquin stated an ordinance concerning golf carts requiring a licensed driver to drive the carts, he asked council to ask the Sheriff's Dept. to add patrols to help enforce the ordinance.

Alderman Ehmann made the motion to approve the Ordinance adopting the Water Conservation Plan and Drought Contingency Plan. Alderman Robbins seconded the motion. The motion passed unanimously.

Item A: Approve/Disapprove appointment to Planning and Zoning to fill vacancy

Alderman Robbins made the motion to appoint Susan Hewitt and J D Warren to the committee. Alderman Tucker seconded the motion. The motion passed with Alderman Merrick, Tucker and Robbins voting in favor of the motion. Alderman Ehmann voted against the motion.
  
- XI. Mayor Gillespie adjourned the meeting at 7:18 p.m.


