Item B: Parks & Recreation reported the multi-use court will be 30 ft X 60 ft. with a structure to cover it; a sample of the court was handed around. Contractors will be contacted to start the project with an estimated completion in three months.

VIII. New Business: Discussion and Possible Action

Item A: Approve/Disapprove CenterPoint Energy 2017 Annual GRIP Adjustment for the South Texas Division
