## CITY OF INGLESIDE ON THE BAY CITY COUNCIL MEETING May 19, 2020

- I. City Council Meeting was called to order by Mayor Ehmann at 7:00 p.m.
- II. Mayor Ehmann led the Pledge of Allegiance.
- III. An invocation was not given
- IV. Roll Call: Present were: Mayor Ehmann, Alderman Cain, Nyberg, Robbins and Daley. Alderman Wilder was absent.
- V. Minutes of Previous City Council Meeting of March 17, 2020 were approved as corrected. Minutes of Previous City Council Meeting of March 23, 2020 were approved as written.
- VI. Treasurer Report was not given.
- VII. Citizen Participation

Item A: Approve/Disapprove Resolution Denying AEP's to Amend its Distribution Recovery Factor Discussion of the resolution and clarification occurred. Alderman Nyberg made the motion to approve the resolution. Alderman Daley seconded the motion. The motion passed unanimously.

## Item B: Update on 321 N Sandpiper

Mayor Ehmann stated permits were issued for sheds; as far as the City is concerned there are no ordinance violations. According to the City Attorney any further action will need to be through a formal complaint by a citizen through the court system if the evidence is brought through the City Attorney. Mr. Stork asked how to proceed with a formal complaint. It was explained a formal
