and approved as the 2001/2002 Certified Appraisal Tax Roll for Ingleside on the Bay.



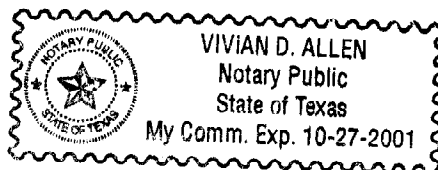
