ORDINANCE 2004-01

AND ORDINANCE AMENDING ORDINANCE NO. 2003-05 ESTABLISHING A RATE FOR SANITARY SEWER SERVICE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF INGLESIDE ON THE BAY:

SECTION 1. That Ordinance 2003-05 is amended by amending Section 1 there of to hereinafter read as follows:

Section 1. Charge for Sanitary Sewer Service. The charge for sanitary sewer service shall be based on the averages of the winter months during the summer months, when lawn watering usage is higher, or actual usage, which ever is less. During winter months charge for sanitary sewer service shall be based on the amount of water usage as measured by each individual water meter. In addition to the charge for water, a charge shall be made to each account as follows:

\$25.00 for the first 2,000 gallons of water

\$ 2.00 for each additional 1,000 gallons.

Each account will be billed monthly for sanitary sewer service in accordance with the rules, regulations and schedule for billing for water service. Failure to pay the monthly fee shall result in termination of water service to the account billed. Service shall not be reinstated at any location so terminated until and unless the full bill, water and sewer, is paid and brought current, including any required disconnect and reconnect fees.

Section 2. All other parts of Ordinance 2003-05 shall remain in full force and effect it being the intention of the City Council to keep such Ordinance in full force and effect as amended here in.
