AN ORDINANCE RELINQUISHING AUTHORITY TO REGULATE THE ON-SITE FACILITY PROGRAM (OSSF)IN ACCORDANCE WITH PROVISIONS OF THE HEALTH AND SAFETY CODE, 366, ON-SITE SEWAGE DISPOSAL SYSTEMS; PROVIDING FOR PUBLICATION

WHEREAS, due notice was given of a meeting and public hearing to determine whether the City of Ingleside on the Bay, Texas should relinquish authority to regulate the On-Site Facility Program (OSSF) in accordance with provisions of the Health and Safety Code, 366, On-Site Sewage Disposal Systems; and

WHEREAS, said meeting and public hearing were held in accordance with the notice thereof and the evidence and arguments there presented were considered by the City of Ingleside on the Bay, Texas; and

WHEREAS, the City of Ingleside on the Bay, Texas finds that the use of On-Site Sewage Facilities in the City of Ingleside on the Bay, Texas, is no longer necessary due to the installation of city wide sewer services requiring property owners to connect to the city sewer system by Ordinance 199-01.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF INGLESIDE ON THE BAY:

SECTION 1. THAT the matters and facts recited in the preamble hereof are hereby adopted and found and determined to be true and correct.

SECTION 2: THAT Ordinance 1997-06 is hereby repealed.

SECTION 3. This Ordinance shall be effective upon adoption and publication of the caption thereof in the official newspaper of the City.
