ADOPTING THE BUDGET FOR THE NEXT FISCAL YEAR

AN ORDINANCE MAKING APPROPRIATIONS FOR THE SUPPORT OF THE CITY OF INGLESIDE ON THE BAY FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019 ADOPTING THE ANNUAL BUDGET OF THE CITY OF INGLESIDE ON THE BAY, SAN PATRICIO COUNTY, TEXAS FOR THE 2018/2019 YEAR.

That the appropriation for the fiscal year beginning October 1, 2018 and ending September 30, 2019, for the support of the general government of the City of Ingleside on the Bay, Texas, be fixed and determined for said terms in accordance with the expenditures shown in the City's fiscal year 2018/2019 budget, a copy of which is appended hereto as Exhibit A.

SECTION II. That the budget, as shown in words and figures in Exhibit A, is hereby approved in all respects and adopted as the City's budget for the fiscal year beginning October 1, 2018 and ending September 30, 2019
